The JazzHR is an online recruitment tracking system, which will provide a streamlined process for candidate sourcing, employer branding, interviews and assessments, compliance and reporting, and collaborative hiring. This technology will improve the recruiting experience for all users, including candidates, hiring managers, interview teams, and HR. Our current process relies on manual data entry into Miami County's website for postings and spreadsheets to track applications and requires candidates to create one profile for each job to which they wish to apply. Applicants will also be able to receive notifications for postings based on their preferences. Real-time reporting will allow better tracking of recruiting spend, HR activities, and other metrics. Data Board provided an Administrative Approval on August 9, 2023. Costs not to exceed \$2,436.00, to be paid from Fund 01098.
